## Practice Overview

Matthew's practice encompasses financial remedies, private law children, and jurisdiction disputes whether finance or children related.

He has particular expertise of undertaking cases and nuptial agreements for HNW and UHNW individuals involving assets of up to £1bn. He also has significant interest in internal and external relocation cases that include SEN elements – Matthew is a champion for Neurodiversity in Law. Additionally, Matthew is adept at handling family cases with ongoing parallel proceedings (such as immigration).

Matthew joined 1GC after five years away from the Bar working firstly as a Partner at Forsters LLP and latterly as Head of Family at Wedlake Bell LLP. Prior to this, Matthew spent 10 years at a specialist matrimonial finance chambers.

Having spent 5 years instructing counsel on matters, Matthew loves fully integrating himself into a team with the instructing solicitors on any matter. He knows what life on the other side of the profession is like and how much instructions matter and are precious.

Matthew is qualified as a mediator for both civil and family disputes and is by now an experienced mediator having conducted a number since he completed his training. Matthew can be instructed as a private FDR judge or as a direct access barrister within 'one lawyer' models to avoid conflict.

Matthew has been recognised in 2024 Spear's 500 index as a top recommended family law barrister.

## Direct Access

Matthew undertakes some direct access work, particularly that around nuptial agreements which he has significant experience of drafting and negotiating due to having spent 5 years in private client firms in London.

He also enjoys giving early strategic advice to clients in the immediate aftermath of their divorce, or pre-separation, often before they instruct a solicitor.

When appropriate, Matthew refers direct access clients to trusted solicitors.
